## SPECIAL MEETING MINUTES

June 6, 2017

**I. Call to order**

Mayor Miller called to order the special meeting of the Harris City Council at 7:03 p.m.

**II. Pledge of Allegiance**

Everyone joined in the Pledge of Allegiance.

**III. Roll Call**

Treasurer Balfany conducted roll call. The following members were present: Mayor Miller, Councilmembers Payne, Sculley, Rossini and Williams. Treasurer Balfany announced a quorum of the Council was present.

**IV. Special Agenda**

• **Fire Department Position Interviews**

The Fire Department personnel had been asked to apply for any officer positions that they were interested in. The City Council asked each applicant to interview

- Trever Williams - applying for 1st Assistant Chief position.
- Steve Nelson - applying for Training Captain position.
- Henry Gregoire - applying for Fire Chief position
- Eric Lamwers - applying for Safety Captain position.
- Rob McMillen - applying for Engineer position.
- Brian Swanson - applying for Safety Captain position.
- Larry Eckl - applying for Fire Chief position.

When the interviews were completed, the Council discussed the candidates' qualifications.

Mayor Miller made the motion to establish a Safety Committee, rather than having a Safety Captain, consisting of the Fire Chief, 1st Assistant Chief and Training Captain. Councilmember Payne seconded the motion. All in favor, motion carried.

Councilmember Payne made the motion to appoint Trever Williams as the 1st Assistant Chief. Councilmember Rossini seconded the motion. Mayor Miller and Councilmembers Payne, Rossini and Sculley voted for the motion. Councilmember Williams abstained. Motion carried.

Councilmember Rossini made the motion to appoint Gabi Isaac as the Department Secretary. Councilmember Williams seconded the motion. All in favor, motion carried.

Councilmember Rossini made the motion to appoint Steve Nelson as the Training Captain. Councilmember Williams seconded the motion. All in favor, motion carried.

Councilmember Rossini made the motion to appoint Rob McMillen as the Engineer. Councilmember Payne seconded the motion. All in favor, motion carried.

Mayor Miller made the motion to ask Eric Lamwers to be the EMR Captain. Councilmember Payne seconded the motion. All in favor, motion carried.

Councilmember Sculley made the motion to appoint Larry Eckl as the Fire Chief. Councilmember Payne seconded the motion. Councilmembers Sculley, Payne and Rossini voted for the motion. Mayor Miller voted against the motion. Councilmember Williams abstained. Motion carried.

Councilmember Rossini made the motion to review the fire department appointments annually. Councilmember Payne seconded the motion. All in favor, motion carried.

**X. Adjourn**

Mayor Miller made a motion to adjourn the meeting. Councilmember Williams seconded the motion. All in favor, motion carried. There being no further business, Mayor Miller adjourned the meeting at 10:08 p.m.
