- **I.** Call to Order: Mayor Carlson called the meeting to order at 7:00 pm.

VI. Regular Agenda

- **A. JJ Hastings update and information** Chief Hastings thanked the council for the last year and half of supporting his rebuilding of the Fire Department. Now that they are under new leadership, they are still in need of the councils' support, please continue to help them to become a stable cohesive team.
- **B. 438th city lot information** the mayor contacted three relators and is still waiting for two realtors to return with written proposals. Amy Berry out of North Branch sent a presentation and suggested listing the lot for \$85,900. Sculley made a motion to spend an additional \$1000 to add spray foam insulation to the well house. Maack seconded the motion, all in favor, motion carried.
